

## COVID-19 CONSENT FOR PATIENTS AT UPTOWN MEDICAL AESTHETICS

As a matter of transparency, we are mandating that you sign a COVID-19 waiver. We are following all Federal (CDC), and Colorado State (DORA, CDPHE) rules and regulations. In particular we are strictly following CO Executive Orders D 2020 044/45 and CDPHE PHO 20-28/29 regarding elective Medical Offices and Services. **If you do not wish to sign this form, you will not be offered aesthetic services in our office at this time.** Sars-CoV2 causing COVID-19 is a new and potentially threatening disease. If acquired, you may have no symptoms or develop life or limb/organ threatening complications, disability, job loss, family loss, and death. The purpose of this COVID-19 waiver is to allow you informed consent regarding your voluntary wishes to receive medical grade aesthetic services at our office. Such services are not risk free. In addition to usual aesthetic risks, you are now at risk for COVID-19, despite any and every best effort on our behalf to protect you in our spa. COVID-19 testing detection methods may miss COVID-19 disease. Due to your voluntary consent to receive such aesthetic services, even despite the CDC, DORA, CDPHE best intent, actions and our ability to follow those government orders, we cannot accurately predict whom would or would not acquire COVID-19, or whom transferred COVID-19 to whom.

Therefore, as a patient in our office, you are fully agreeing to the terms below without exception:

1. You fully release and hold harmless: the owner and estate, business, insurance companies, all associated parties, all assignees, its staff, its Medical Director Michael Iannotti MD and his estate, his insurances, his assignees, his companies, the business landlord, landlord insurance companies, from any and all complications of suspected or confirmed Sars-CoV2 virus and COVID-19 disease, including but not limited to the following: doctor fees, hospital fees, surgery fees, medicines, resulting employment losses and claims, disability losses and claims, life insurance losses and claims.
2. You will also agree that any frivolous or non-frivolous attempts to seek legal action against the aforementioned groups in item 1 above, will result in your voluntary reimbursement for any and all legal, court, attorney and associated fees spent on our behalf, in defense of your own actions and your legal pursuits. Additionally, the owner and its Medical Director, Michael Iannotti, MD, will reserve all legal rights and remedies regarding: all losses of their revenues, incomes, protections of their legal rights including defamation, slander, libel, illegal uses of social medias, their legal fees, court fees, associated fees, and all losses of any kind, due to your legal actions or social media uses against them. You voluntarily would submit that your actions are directly causal to their losses and would agree to be held fully financially responsible for all said losses to Uptown Medical Aesthetics and their Director, Michael Iannotti, MD.
3. You submit that you are mentally competent, that you fully have read and understand this document and its implications for your future and health. With your signature, you fully understand and agree to its terms, without exception.
